FUMIGATION PREPARATION INSTRUCTIONS

Dear Valued Customer: Thank you very much for deciding upon Aloha Termite & Pest Control to fumigate your house. We are very concerned about complying with the labels, performing quality work, safety and protecting your house. In order to accomplish this we need your help in preparing the interior and exterior before we fumigate.

A. INTERIOR PREPARATION

- _____ 1. Remove people, animals, birds, fish, plants, cats (pets & strays), etc.
- _____ 2. Remove or bag all medicines, vitamins, etc.
- _____ 3. Unzip or remove airtight plastic covers on pillows, mattresses, etc.
- _____ 4. Remove valuables such as cash, jewelry, etc.
- _____ 5. Food items must be bagged in Nylofume bags furnished by Aloha Termite & Pest Control. Follow the attached instructions.
 - _____ a. Candies, crackers, cereal, flour, bread, saimin, etc. in box or package.
 - _____ b. Frozen meat, produce, leftovers, ice cubes.
 - _____ c. Refrigerated food—produce, meat, etc.
 - _____ d. All other food items including snacks stored in other living areas.
 - _____ e. Items in unopened sealed bottles, unopened cans are safe from fumes.

B. EXTERIOR PREPARATION

- _____ 1. Remove, cut back or tie plants 2 feet away from house.
- _____ 2. Plants under eaves must be 2 feet away and no taller than 5 feet high.
- _____ 3. Thorny bushes (roses, privet, bougainvillea, etc.) must be cut to 3 feet height and 2 feet away.
- _____ 4. Remove mondo grass from within 2 feet away. Fumigant may damage/injure mondo grass beyond 2 feet away.
- _____ 5. Scrape away gravel, cinders or rocks down to the soil 2 feet along border of the house.
- _____ 6. Remove trellis, climbing vines and plants from within 2 feet of house.
- _____ 7. Remove sprinkler heads from within 2 feet away from house.
- _____ 8. Cut back vines or ground cover to the soil 2 feet away from house.

C. ROOF PREPARATION

- _____ 1. Remove antennae and tall obstructions.

D. FENCES

- _____ 1. Remove or detach fence 1 foot away from house.

E. GAS APPLIANCES — MUST BE TURNED OFF

- _____ 1. Estimator to show location of valve.
- _____ 2. Fumigator to turn off valve.
- _____ 3. Homeowner to call GASCO at 526-0066 to restore gas service after fumigation.

F. ALARMS — MUST BE TURNED OFF

- _____ 1. Smoke, fire, security, etc. must be turned off.
- _____ 2. Remove batteries from portable alarms.

EMERGENCY # _____

G. ANIMAL DROPPINGS

- _____ 1. Animal droppings must be removed from yard.

H. ACCESS TO BEGIN FUMIGATION

- _____ 1. Someone must be home when fumigators arrive.
- _____ 2. Unlock all doors in house, storage, closet, etc.

I. DAMAGES

- _____ 1. Due to the nature of work involved, roof, gutters, solar, etc. may be damaged. Aloha Termite & Pest Control cannot guarantee the original condition or be responsible for damages.

J. POSTPONEMENT — Aloha Termite & Pest Control RESERVES THE RIGHT TO:

- _____ 1. Postpone fumigation due to inclement weather, unsafe roof conditions, failure to prepare premises, etc.
- _____ 2. Aloha Termite & Pest Control will not be held liable to reimburse or pay for hotel or lodging, meals, etc. whenever a job is postponed due to conditions beyond our control.
- _____ 3. Postponed jobs shall be re-scheduled on mutually agreed date.

K. SCHEDULING

- _____ 1. Customer shall be notified of fumigation date and estimated time of job.

L. RE-ENTRY

- _____ 1. Time to re-enter is normally 6 hours after uncovering. Usually re-entry is in the late afternoon.

M. AERATION

- _____ 1. All drawers, cabinets, cupboards, closets, desks, etc. shall be partially open for proper aeration.
- _____ 2. Open all window & attic doors.

N. FAILURE TO PREPARE PREMISES

- _____ 1. Aloha Termite & Pest Control will not be held responsible for damages to plants, objects, structures, etc. from failure to comply with the preparations instructions.

O. CONFIRMATION

- _____ 1. I have read and will adhere to the instructions as described in the "Vikane Fact Sheet".

I hereby acknowledge receipt of Aloha Termite & Pest Control's fumigation Preparation Instructions and Vikane Fact Sheet, and agree to prepare the premises in accordance with the instructions. I further agree to accept the conditions specified in the Fumigation Preparation Instructions.
